## NOTICE IN ACCORDANCE WITH ART. 13 OF EU REGULATION 679/2016

For the ongoing establishment and execution of relations with you, the G.I.O.S.E.G. Association informs you that it is in possession of some of your personal data, also acquired verbally, that is deemed as personal by law.

With reference to such data we inform you that:

- The data you provide will be processed for the purpose of managing relations with our Association and forwarding corporate communications, the magazine, publications and newsletters, as well as invitations to conferences, activities and conventions that will be deemed to be of interest to you.

These data will be processed in writing and / or electronically:

- the provision of the data is mandatory for all that is required by legal and contractual obligations and therefore any refusal to provide or to process them may make it impossible for the Association to carry out the same contractual relationships;
- failure to provide, on the other hand, all data that are not attributable to legal or contractual obligations will be evaluated from time to time by the Association that will determine the consequent decisions related to the importance of the data requested with respect to the management of the commercial relationship;
- without prejudice to the communications and dissemination carried out in execution of legal obligations, the data may be communicated in Italy to credit institutions, professionals and consultants, hardware and software maintainers and persons in charge of processing them;
- the data will be processed for the entire duration of the established contractual relationships and also subsequently for the fulfillment of all legal obligations;
- with regard to these data, you can exercise the rights provided for by art. 13 EU Regulation 679/2016

Art. 7. Right of access to personal data and other rights

1. The interested party has the right to obtain confirmation of the existence or not of personal data concerning him/her, even if not yet recorded, and their communication in an intelligible form.
2. The interested party has the right to obtain the indication of:
  - the origin of personal data;
  - the purposes and methods of the processing;
  - the logic applied in case of treatment carried out with electronic instruments;
  - the identification details of the owner, of the managers and of the designated representative pursuant to article 5, paragraph 2;
  - the subjects or categories of subjects to whom the personal data may be communicated or who can come to knowledge as appointed representatives in the State, managers or agents.
3. The interested party has the right to obtain:
  - updating, rectification or, when interested, integration of data;
  - the cancellation, transformation into anonymous form or blocking of data processed in violation of the law, including those that do not need to be kept for the purposes for which the data were collected or subsequently processed;
  - the attestation that the operations referred to in fields a) and b) have been brought to the attention, also as regards their content, of those to whom the data have been communicated or disseminated, except in the case in which this fulfillment is impossible or involves a manifestly disproportionate use of means with respect to the protected right.
4. The interested party has the right to object, in whole or in part:
  - for legitimate reasons to the processing of personal data concerning him, even if pertinent to the purpose of the collection;
  - to the processing of personal data concerning him for the purpose of sending advertising or direct sales material or for carrying out market research or commercial communication.
