Art. 7. Right of access to personal data and other rights

- 1. The interested party has the right to obtain confirmation of the existence or not of personal data concerning him/her, even if not yet recorded, and their communication in an intelligible form.
- 2. The interested party has the right to obtain the indication of:
- the origin of personal data;
- the purposes and methods of the processing;
- the logic applied in case of treatment carried out with electronic instruments;
- the identification details of the owner, of the managers and of the designated representative pursuant to article 5, paragraph 2;
- the subjects or categories of subjects to whom the personal data may be communicated or who can come to knowledge as appointed representatives in the State, managers or agents.
- 3. The interested party has the right to obtain:
- updating, rectification or, when interested, integration of data;
- the cancellation, transformation into anonymous form or blocking of data processed in violation of the law, including those that do not need to be kept for the purposes for which the data were collected or subsequently processed;
- the attestation that the operations referred to in fields a) and b) have been brought to the attention, also as regards their content, of those to whom the data have been communicated or disseminated, except in the case in which this fulfillment is impossible or involves a manifestly disproportionate use of means with respect to the protected right.
- 4. The interested party has the right to object, in whole or in part:
